

## Did You Hear? Draper and Kramer Promotes Four Executives

Property and financial services firm Draper and Kramer has promoted four key executives to help guide the company's future direction and growth.

The 126-year-old, Chicago-based company promoted **Edward Polich** to executive vice president of real estate, **Blas Puzon** to chief investment officer and **Christine Ramsey** to chief administrative officer. Draper and Kramer also expanded the role of Senior Vice President and Director of Management Services **Julie Stevlingson** to include leading the firm's construction services and property operations.

Each of the four has "made significant contributions to Draper and Kramer's success in recent years," Draper and Kramer President and Chief Executive Officer **Todd Bancroft** said in a statement announcing the promotions.

Polich, a 37-year real estate industry veteran, rejoined Draper and Kramer as chief development officer in 2014. He worked for the firm for eight years in the 1980s before leaving as a vice president. In his new role as executive vice president, Polich will oversee Draper and Kramer's development initiatives and chair its investment committee that evaluates potential transactions.

In his new role as chief investment officer, Puzon will oversee all portfolio management functions including acquisitions, dispositions, property management and asset management. Puzon, who joined Draper and Kramer as senior vice president of acquisitions, oversaw its 2018 purchase of North 680, a luxury rental community in Schaumburg, Illinois, and Burnham Pointe in the Printer's Row section of Chicago.

Ramsey joined Draper and Kramer as senior vice president of human resources in 2016 and led the group when the Chicago Tribune named the firm one of the area's

top workplaces in 2017 and 2018. In her new position as chief administrative officer, Ramsey will lead communications, stockholder relations and risk management as well as continue to oversee human resources operations.

Stevlingson's role was expanded to include construction services and property operations after overseeing Draper and Kramer's residential management portfolio since joining the firm five years ago. Draper and Kramer's residential portfolio comprises 10,000 units in Chicago, Minneapolis, St. Louis and San Antonio. She'll continue to oversee the 1,200 employees in Draper and Kramer's management services division.
